

Halo Hair Extensions Agreement Pt. 1

This Halo Hair Extensions Agreement (this "Agreement") is made between _____ ("The Supplier") and the individual client signing this Agreement ("you" or "client").

1. Halo Hair Extensions supply and fitting.

a) Hair Extensions consist of a large number of strands of some of the finest natural hair available in the world. The Halo Hair Extensions will be matched closely as possible to the hair sample and/or color instructions provided by you, the Client, before or at the time you sign this Agreement.

b) Each Hair Extension will be attached to the strands of your own hair by threading both your own hair and that of the Halo Hair Extensions through a small micro attachment.

c) You will need to return to The Supplier studio every four (4) to six (6) weeks as part of your Halo Hair Extensions aftercare and maintenance program. An average service takes approximately three (3) hours.

d) Gradual replacement of the Hair Extensions will be necessary. Replacement of Hair Extensions normally begins approximately six (6) months from the initial fitting and new Hair Extensions typically last between six (6) and twelve (12) months. The Supplier's then current charges for fitting and replacement of Hair Extensions will apply.

2. The Supplier agrees to:

a) supply you with the designed and manufactured and/or ready-made Hair Extensions described in the Schedule;

b) fit the Hair Extensions by attaching them to the Client's hair by method described in this contract.

3. You agree to:

a) pay The Supplier the deposit upon signing this Agreement;

b) pay the balance of the purchase price on either

i) the date of the fitting the Hair Extensions are completed, or

ii) four (4) weeks from the date The Supplier advises you that your Hair Extensions are available for fitting.

4. You may terminate this Agreement anytime before the manufacturing and/or fitting of Hair Extensions.

a) If you terminate this contract after manufacturing/order of your Hair Extensions has commenced, you will be held liable for all costs incurred (outstanding balance and any express surcharges).

5. By signing this Agreement, you acknowledge and agree to the following:

a) you have received, read and understood the "Instructions for Care of Hair Extensions" attached to this Agreement.

b) The Supplier Consultant and/or Stylist has informed you of the instructions contained in the "Instructions for Care of Hair Extensions;"

c) damage may occur to both the Hair Extensions and your own hair if you do not comply with the "Instructions for Care of Hair Extensions;"

d) if you change the color of your own hair subsequent to signing this Agreement but prior to fitting, it may not be possible to change the color of the Hair Extensions to match the new color of your own hair;

e) if you change the color of your hair after manufacturing/order of the Hair Extensions have commenced, the re-coloring (if possible) or replacement of the Hair Extensions will be at your sole expense in accordance with The Supplier's then current fees;

f) you understand that it is necessary to return to a The Supplier Studio on a regular basis in order to comply with your Hair Extensions aftercare and maintenance program;

g) if you fail to comply with The Supplier's aftercare and maintenance program, you may cause damage to your Hair Extensions and/or to your own hair;

h) The Supplier will not be liable for any damage to the Hair Extensions or your own hair which is caused by your failure to comply with the "Instructions for Care of Hair Extensions," the Hair Extensions aftercare and maintenance program, or the advice of your Consultant and/or Stylist.

i) Any dispute or claim arising out of or related to the goods or services to be provided by The Supplier to you under this Agreement shall be decided through binding arbitration in the jurisdiction of the supplier in accordance with the rules and regulations of the American Arbitration Association ("AAA"). You hereby agree to waive any right or claim to adjudication by jury of any claim or cause asserted against The Supplier arising hereunder.

j) In any judicial proceeding arising out of or related to your failure to pay The Supplier any amounts owed under this Agreement, the prevailing party shall be entitled to recover all reasonable costs incurred pertaining to such proceeding including attorney's fees and expenses and any costs associated with collection of such amounts.

k) Only credit cards or cash will be accepted as a balance payment.

Halo Hair Extensions Agreement Pt. 2 INSTRUCTIONS FOR CARE OF HAIR EXTENSIONS

1. Daily Care:

The client must ease out any tangles or any matting around the beads once a day, as demonstrated by you're the Supplier Consultant and/or Stylist. If this is not done, serious matting can develop. Removing such matting may cause damage to the Hair Extensions and the Client's own hair.

2. Washing and Styling:

The Client must follow the directions provided by The Supplier Consultant and/or Stylist and only use the products approved by you're the Supplier Consultant and/or Stylist in order to prevent damage to the Hair Extensions and the Client's own hair.

3. Coloring and Perming:

Serious damage may be caused to your own hair and the Hair Extensions by chemical treatment at home or by hairdressers not thoroughly familiar with Hair Extensions. This is because color or perming chemicals may be trapped in the micro-cylinders, where they can continue to chemically affect and possibly damage to the Hair Extensions and your own hair. All chemical treatments of your hair should be carried out at a The Supplier studio or salon, or by a professional hairdresser approved by your the Supplier Consultant and/or Stylist as competent to treat Hair Extensions. The range of color changes possible to Hair Extensions is limited by certain chemical factors understood by you're the Supplier Stylist.

4. Cutting:

Hairdressers not familiar with Hair Extensions may damage it by cutting it too short, or by incorrect technique. Before having your hair and Hair Extensions cut by a hairdresser who is not a The Supplier Consultant and/or Stylist, you must ask your non The Supplier hairdresser to contact your The Supplier Consultant and/or Stylist to discuss the proposed style.

5. Brushing Technique:

Brushing must only be carried out by using the brushing technique given by The Supplier (or equivalent).

6. Swimming:

When swimming, it is advisable to braid your Hair Extensions as this will prevent knotting. Always remember to rinse the chlorine or salt water out of your Hair Extensions after swimming and apply a good conditioner or detangling spray.

7. Sleeping:

It is advisable to loosely braid or pony tail the hair when sleeping. We recommend you make extensive use of the silk pillow case provided by The Supplier. This smooth silky surface is non-abrasive and will assist in taking care of your Hair Extensions while sleeping.

8. Halo Hair Extensions Aftercare and Maintenance Program:

As your hair grows, the attachment micro-cylinders attaching the Hair Extensions will move further away from your head along with your own hair. This can increase the traction on your own hair. It is necessary for you to return to a The Supplier Studio every four (4) to six (6) weeks, or as advised by you're the Supplier Consultant and/or Stylist to have the attachment cylinders returned to their original position or replaced. Failure to do this may result in tangling and/or loss of some of your own hair. Should you require assistance in styling you may return to your stylist within one week of the initial fitting date to assist with any inquiries you may have. This will also determine the suitable forward care regime at home and in The Supplier Studio. It is essential that you call you're the Supplier Consultant and/or Stylist if you have any questions.
